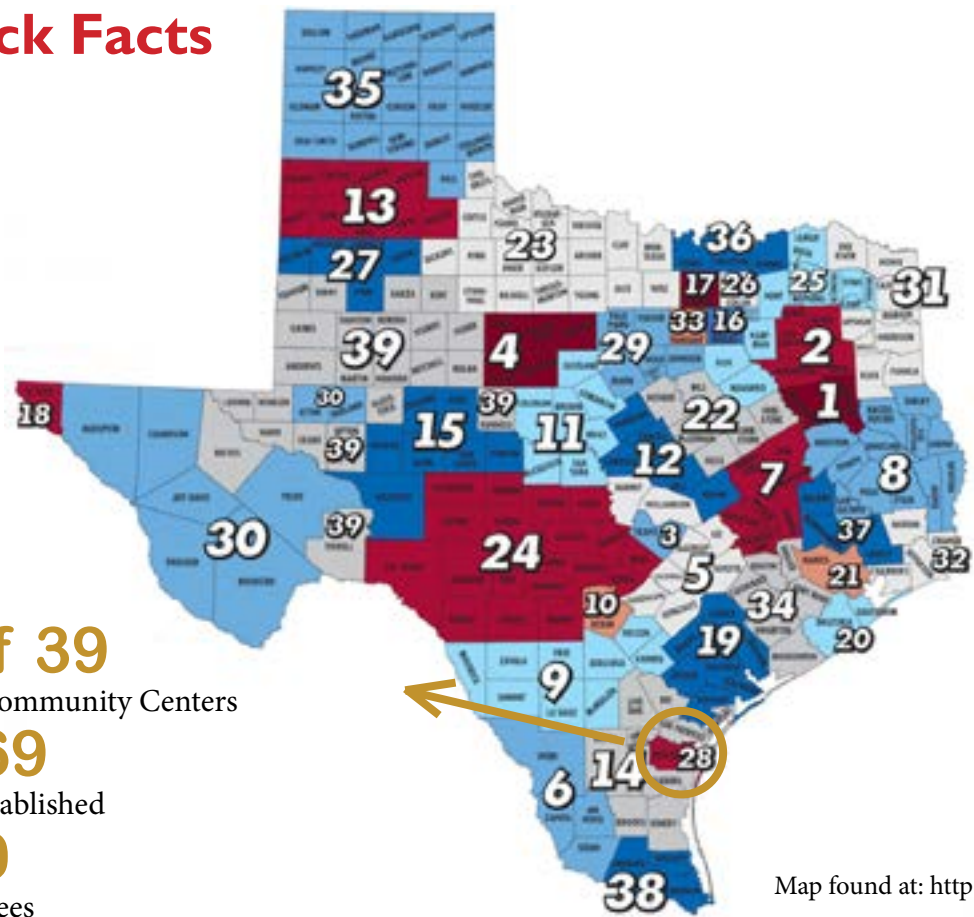

NATIONAL STATISTICS

MENTAL HEALTH

- 1 in 5** American adults experienced a mental health issue.¹
- 1 in 10** Young people experience a period of major depression.¹
- 10th** leading cause of death in the United States is suicide.¹
- 26%** of homeless adults staying in shelters live with serious mental illness.²
- 20%** of state prisoners have "a recent history" of a mental health condition.²

INTELLECTUAL & DEVELOPMENTAL DISABILITY

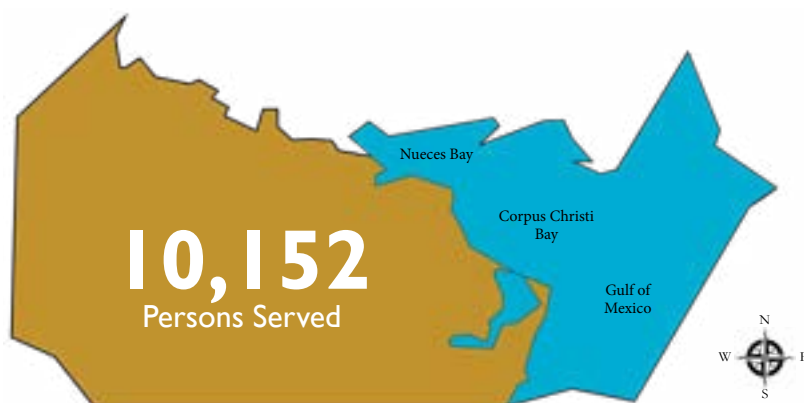
- 1 in 59** children is diagnosed with an autism spectrum disorder (ASD).³
- 6.5 million** people in the United States have an intellectual disability.⁴
- 35%** of individuals with IDD living outside of institutions also have a co-occurring mental illness.⁵
- 40,000** people with IDD receive some type of long-term services and supports in Texas.⁶
- 200,000** people are waiting for long-term services and supports across the state of Texas.⁷

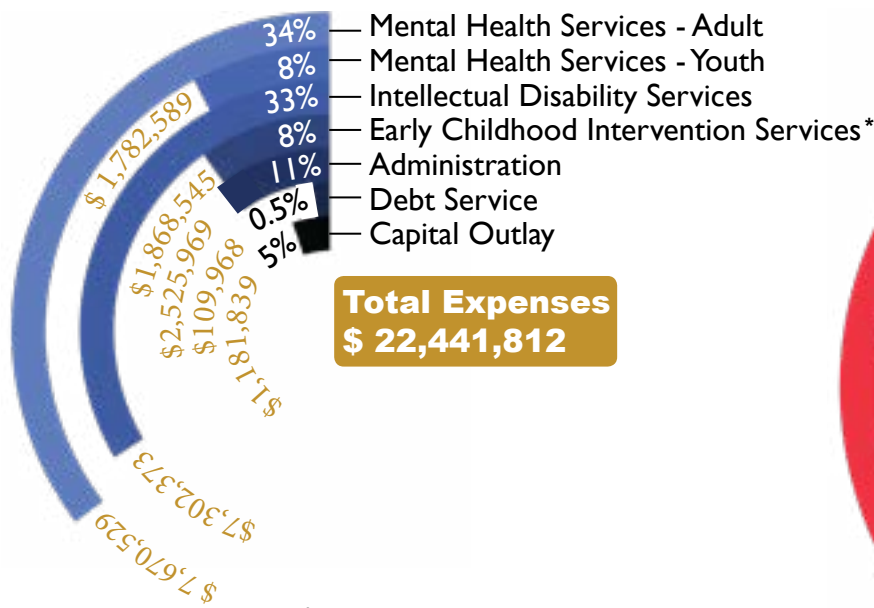

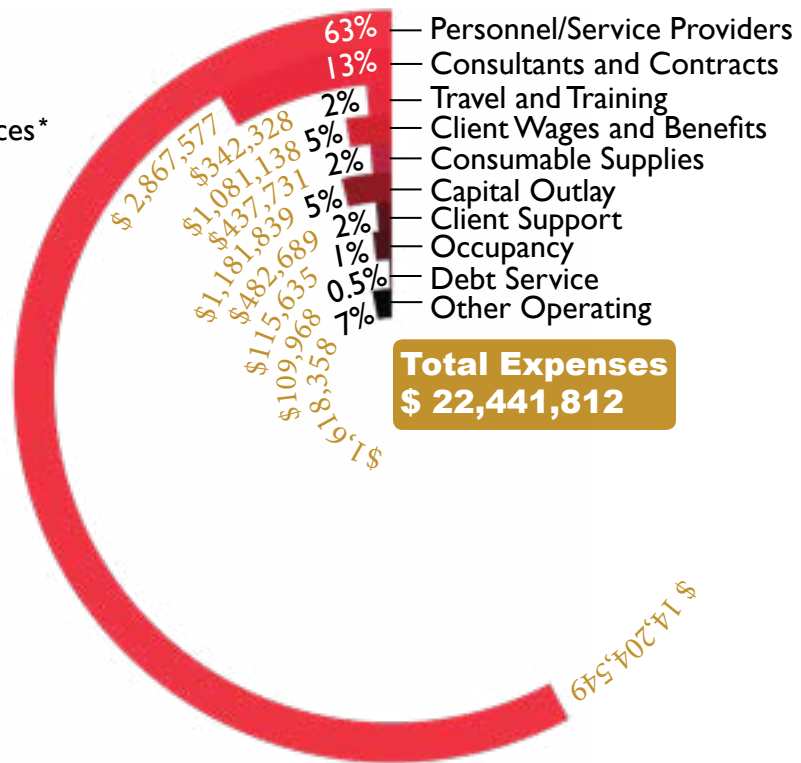
